Prof. Kumar Molugaram, the Chairman of the Academic Council gave the welcome address & introduced the members of the newly constituted body including external members and the Special Invitees. He gave the following information for the benefit of the new members.

- A brief history of the College beginning from 1929, till date.
- As on date this college has 6 Under Graduate and 7 Post Graduate courses.
- The college got an extension of UGC Autonomy for a further period from 2016 to 2022.
- The next semester classes for both B.E. /M.E. will commence from 1st July 2019.
- As per the AICTE norms a three week Induction Programme for a fresh batch of B.E. students of 2019-2020 will be conducted by the college.
- As of now there are two schemes of examinations vogue, i.e.,
 - (i) New AICTE Scheme, from 2018-2019
 - (ii) Choice Based Credit System (CBCS Scheme) from 2015-2016.

Subsequently the Principal requested the Director, CDAAC, to address the members which shall be follow by the Power Point Presentations by the Chairpersons, Board of Studies (A) of the various Departments to present the B.E Scheme for 1st to 8th Semesters and M.E/M.Tech Scheme.

Prof. P.V.N. Prasad, Director, CDAAC explained briefly the various aspects with regards to the introduction of New AICTE Model Curriculum for B.E. students from the Academic year 2018-2019 and M.E./M. Tech students from the year 2019-2020.

The number of credits given have been reduced from 200 to 160 in the new curriculum and internship in the 7th & 8th semester has been mandatory. He also expressed the view that a uniform decision would be taken with regard to the award of the credits by the Department.

Item No. -6 Recommendations of the Board of Studies in Mechanical Engineering.

Prof. B. Hadya Chairperson, Board of Studies (A) gave the Power Point Presentation on the recommendations of the Board of Studies in Mechanical Engineering with respect to B.E. Scheme for 1st to 8th semesters and scheme for M.E.

The chairman informed all the Head of the Departments & Chairpersons Board of Studies, that the syllabus for all the M.E / M. Tech courses has to be finalized keeping in view the suggestions given by the external members within a month and to be presented to the next Academic Council for its approval.

The external members pointed out that the students who goes an internship is obtaining only the attendance certificate from the Industry / office, instead were of the opinion that the students should also get credits from the Industry / office based on their performance (credits allotted by the Department).

The Director, CDAAC, expressed that uniform decision would be taken with regard to the award of the credits by the Department.

During the course of deliberations on the B.E. / M.E / M. Tech Schemes of the various departments the following suggestions / feedbacks were given by the external members / nominated members of the August Body:-

- √ The course titles with similar names within the same program and other programs may be recast in relevant to the branch of Engineering.
- √ The syllabus for the subject "Intellectual Property Rights" shall be different for UG & PG courses.
- $\sqrt{\ }$ The nomenclature of the papers, particularly the Elective papers should be chosen as per the curriculum.
- √ The students who go on internship should be given credits by the Industry / Office concerned based on their performance apart from the attendance certificate.
- $\sqrt{}$ A uniform decision should be taken with regards to the award of Credits by the department for internship.

Item No. 7

Rules & Regulations for the four year B.E Degree Programs w.e.f. the Academic year 2018-2019.

The Rules & Regulations of the four years B.E Degree Programme was approved, which was with effect from 2018-2019, with emphasis on the following changes which were incorporated and brought to the notice of the Academic Council.

- The Candidates who fails to fulfill all the requirements for the award of the degree as specified hereinafter within (N+2) academic years from the time of admission, will forfeit his/her seat in the program and his/her admission will stand cancelled. (here 'N' stands for the normal duration of the course)
- The fee for condonation of attendance on medical grounds shall be Rs. 2000/-(Rupees Two Thousand Only) payable through Demand Draft drawn in favour of the "Principal, UCE, OU"
- Only a student securing highest CGPA in single attempt is eligible for award of God Medal. The students re-admitted are not eligible for the Award of Gold Medal.

<u>Item No. 8</u> Permission to submit M.E Thesis beyond the stipulated period to students at Dept. of BME, Civil Engg., CSE, & EEE.

The matter was considered and it was resolved to accorded permission to M.E/M.Tech students of the following Departments, to submit their dissertation Thesis beyond the stipulated period and to submit the same within two months from the date of Academic Council, subject to the condition that the candidates have cleared all the subject backlogs, if any, within in the stipulated period.
