Suggestions / opinion by the Chairperson, Governing Body:

The Governing Body expressed their concern on the repairs to be taken up for the college buildings, especially Civil Department Since, the repairs involve a huge expenditure, and they suggested that the College can contact the alumni for funds.

• It was suggested that a Committee be formed with all the Head of the Departments to prepare a Detailed Project Report on the future needs in terms of Non-Teaching / Technical staff, Infrastructure, Maintenance of Building including repairs etc. The Detailed Project Report may then be forwarded to the Alumni with a request to fund the college, for taking up the civil works.

Any alumni donation should be routed through the Principal and the purpose should be mentioned clearly by the donor / Alumni.

The Principal was requested to circulate a letter to all the Heads, that the funds from the alumni funds should be routed through Principal, even if it is meant for individual departments thus ensuring transparency.

They also expressed concern on the shortage of Technical Staff in the department Laboratories. They suggested that after taking the requirement of Technical manpower from the individual departments the matter may be taken up with the Vice-Chancellor and figure out an alternate method like outsourcing and get the necessary permission from O.U authorities.

Before concluding the meeting, Prof. T. Tirupathi Rao, thanked the Vice-Chancellor for appointing him for another term on the Governing Body of the College. The external members Sri. Bikshapathi Kondai & Sri. Devendra Surana also deemed it their privilege to be on the Governing Body for another term of 2 years. They pointed out that 'alumni' is the strength of the College and the onus of having interaction with them in order to procure funds for the betterment of the college lies with the Principal.

Prof. Kumar Molugaram, Principal responded by saying that it is indeed a privilege to have Prof. T. Tirupathi Rao & all the other esteemed members on the Governing Body of the college and sought their valuable inputs, especially the holistic ideas of the Chairperson, so that the College can reach greater heights in academics.

The meeting ended with an vote of thanks by the Principal.
