- 1. As per the guidelines of the Convener, TGEAPCET-2024 Admissions, candidates, who have not taken admission anywhere so far, are **only** eligible to attend the Institutional Spot Admissions at the Assembly Hall, Main Building, University College of Engineering, Osmania University.
- 2. Candidates belonging to other state and completely studied there (Other State) and whose parents belong to other state and residing in other state are not eligible for spot admission.
- 3. Candidates shall not be allowed for spot admission without verifying original certificates.
- 4. Tuition Fee Reimbursement is not applicable to the candidates admitted under Institutional Spot Admissions.
- 5. Hostel Facility is not provided to the candidates.
- 6. Interested and eligible candidates are advised to report at the Assembly Hall, Main Building, University College of Engineering, Osmania University at **11 a.m. on 02-09-2024 (Monday)** and fill up the relevant application form.
- 7. The candidates need to submit the filled in application form along with the registration fee of Rs.1000/- at the registration desk (non-refundable), then only the candidates are eligible for counseling. The filled in application should submit on the spot by 1.00 p.m. sharp to finalize the merit list. After 1.00 p.m. no candidate is permitted for registration.
- 8. Filling in application form and registration do not automatically guarantee any admission to the student for B.E. I Year.
- 9. Certificates to be verified at the time of Registration

 - b) SSC & EQUIVALENT MEMO (ORIGINAL)
 - c) INTER MEMO SHORT OR LONG (ORIGINAL)
 - d) STUDY / BONAFIDE / CONDUCT CERTIFICATE (ORIGINAL)
 - e) TRANSFER CERTIFICATE (ORIGINAL)
 - f) CASTE CERTIFICATE (Photo COPY) IF APPLICABLE
 - g) INCOME CERTIFICATE (Photo COPY) IF APPLICABLE
- The vacancies will be filled first with the candidates qualified in TGEAPCET- 2024 in the order of merit and passed in qualifying examination i.e., 10+2 or its equivalent with group subjects as Mathematics, Physics and Chemistry and possessing 40% (39.5% & above can be taken as 40%) marks in group subjects in respect of SC/ST/BCs and 45% (44.5% and above can be taken as 45%) for others eligible for Spot Admissions.
- 11. If the vacancies are still left, candidates without TGEAPCET-2024 Rank and passed qualifying examination i.e., 10+2 or its equivalent in the order of merit with group subjects as Mathematics, Physics and Chemistry and possessing 40% (39.5% & above can be taken as 40%) marks in group subjects in respect of SC/ST/BCs and 45% (44.5% and above can be taken as 45%) for others shall be considered for admission.
- 12. Further the candidates admitted during institutional spot admissions are hereby informed that their spot admissions are subject to ratification by the Convener, TGEAPCET-2024 Admissions. In case of spot admission given to a particular candidate is not ratified by the Convener, he / she has to quit the college immediately.
- 13. Candidates possessing intermediate or its equivalent certificates other than those issued by the Board of Intermediate Education, Telangana / A.P shall be asked to get the Equivalency Certificate from Board of Intermediate Education, Telangana before granting admission.



- 14. The University reserves the right to cancel the admission of the candidate at any stage if and when it is detected that the admission is against rules or if it is subsequently found that any of the statements made in the application is incorrect and false
- 15. The Admission committee constituted by the College shall decide about all the matters pertaining to admission during counseling and the committee decision shall be final and binding.
- 16. Call for counseling does not guarantee any admission.
- 17. The Provisionally admitted candidate shall pay the full fee i.e. Tuition Fee, Autonomous Fee and Convener processing fee as detailed below:

ANNEXURE TGEAPCET- 2024 (ADMISSIONS)

GUIDELINES FOR SPOT ADMISSIONS TO BE FILLED DURING INSTITUTIONAL SPOT ADMISSIONS

In any category (OC /BC/SC/ST/NCC/CAP/Sports) seats, which are earmarked for women candidates, are to be offered first to women candidates only. If women candidates are not available in that category then the seats are to be offered to male candidates. The women candidates are also eligible to opt for male seats (General seats) in the combined rank order in any category (OC/BC/SC/ST/NCC/CAP/Sports) when their own 1/3 quota of seats are completely filled.

If candidates (male/women) are not available in one reservation category, the seats are to be offered to the next reservation category as mentioned below.

(The cycle is to be completed for each category before diverting the seats to "Open Competition" (OC) in each region (Local area). Diversion of "BC" category seats from one region to other regions due to non-availability of candidates in that region is not permitted.)

The cycle is to be completed before allotting the "SC" category seats to the "SC" candidates of the other two local areas in combined rank order if candidates are not available in that local area.

a. If "ST" candidates are not available in one local area, the seats are to be allotted to "ST" candidates of the other two local areas in the combined rank.

- b. If "ST" candidates are not available in any local area then the "ST" seats of each local area are to be allotted to "SC" candidates of the same local area in the combined rank order.
- c. If "SC" candidates are not available in one local area the seats are to be offered to "SC" candidates of the other two areas in the combined rank.
- d. If "SC" candidates are not available in any local area then the seats are to be offered to "ST" candidates of the same local area in the order of merit.
- e. If "ST" and "SC" candidates are not available in any local area then the seats are to be diverted to "OC" (Open Competition) of the concerned Local area and filled.

In case of special (PH, NCC, CAP, Sports) reservation seats, first the seats are to be offered to the candidates (male/female) as per the category of seats earmarked. If candidates are not available in one particular "PH" category the seats are to be allotted to the other "PH" category in the following order.

The cycle is to be completed before diverting them to the general reservation category candidates (Male/Female).

The above procedure is to be followed for "PH" seats in all reservation categories (OC; BC-A/B/C/D/E; SC; ST). Diversion of the special category seats from one category to other category and one local area to other local areas due to non-availability of candidates is not allowed. Candidates with more than 40% disability are only eligible for allotment of seat under "PH" category. The "PH" certificate is to be issued by the District Medical Board Constituted by the Government of Telangana state as the case may be.

In case of non availability of candidates in the concerned category, the seat is to be diverted its main category,

Example: Unfilled BC-B-Girl-CAP is to be diverted to BC-B-Girl.

When general reservation (BC/SC/ST) and special reservation category (NCC/CAP/Sports) seats are diverted to open competition (OC) due to non availability of candidates in a particular local area and there are no takers for these seats (OC seats) in that local area then only these "OC" seats (General reservation/special reservation seats diverted to "OC") are to be filled by the candidates of the other two local areas in the combined merit order treating them as UNR (UNRESERVED) "OC" Seats.
