

Sir/Madam,

The Secretary, University Grants Commission, New Delhi, vide his letter cited has informed that the Commission has observed that universities across the country adopt varying span period within which a student may be allowed to complete a programme to be qualified for a degree. In order to evolve a uniform policy, the Commission had constituted an Expert Committee to consider the issue of determining a uniform span period. On the basis of the recommendations made by the Committee, the university grants commission has formulated guidelines for compliance of the universities.

The matter was placed before the Standing Committee of the Academic Senate at its meeting held on 28-1-2016 which has resolved as follows:

*Resolved to consider and approve the guidelines of University Grants Commission on determination of uniform span period of N+2 years (where N stands for the normal or minimum duration prescribed for completion of the programme), within which students will have to qualify for a degree with effect from 2016-2017 for all UG/PG/Ph.D/Diploma/ PG Diploma and Adv. PG Diploma courses offered by Osmania University. However, the extension of two years will not be applicable to admission into hostel."

You are, therefore, requested kindly to implement the above resolution of the University and take necessary action.
